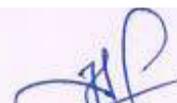

- Leaving certificate after passing Diploma from the Institute last attended.
- Caste Certificate, Caste Validity, Non-Creamy Layer, Income Certificate etc. mandatory for students securing admission under category (i.e. SC/ ST/ OBC etc.)
